A RESOLUTION DESIGNATING THE DEVELOPMENT DIRECTOR AS THE CITY'S OFFICIAL REPRESENTATIVE, AUTHORIZING THE CITY TO FILE A GRANT APPLICATION WITH THE OHIO PUBLIC WORKS COMMISSION CLEAN OHIO CONSERVATION FUND, AND DECLARING SUPPORT FOR THE APPLICATION.

WHEREAS, the State of Ohio, through the Ohio Public Works Commission, administers financial assistance for open space and riparian corridors, through the State of Ohio clean Ohio Conservation Fund, and,

WHEREAS, the City of Bexley is currently implementing a Clean Ohio Grant to restore and preserve portions of the Alum Creek Corridor from Main Street to Livingston Avenue; and,

WHEREAS, the City of Bexley desires financial assistance under the Clean Ohio Conservation Fund to reimburse the cost of restoring and preserving additional portions of the riparian corridor along Alum Creek from Main Street to Livingston Avenue within the City of Bexley.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO,

- <u>Section 1.</u> That the City of Bexley approves filing a grant application to receive financial assistance under the Clean Ohio Conservation Fund.
- <u>Section 2.</u> That the Development Director is hereby authorized and directed to execute and file an application with the Ohio Public Works Commission and to provide all information and documentation required to become eligible for possible funding assistance.
- Section 3. That the City of Bexley does agree to obligate the funds required to satisfactorily complete the proposed project and become eligible for reimbursement under the terms and conditions of the Clean Ohio Conservation Fund.
- <u>Section 4.</u> That the City of Bexley supports the grant application as submitted.

<u>Section 5.</u> That this Resolution is an emergency Resolution, said emergency being the need to submit the application prior to the September 1, 2006 deadline, and will take effect upon its signing by the Mayor.
