## **WITNESSETH**

<u>Section 1</u>. David R. Ahlum shall, for the consideration hereinafter stated, furnish to the City of Bexley, Ohio, and the inhabitants thereof, consulting arborist services as are requested including tree evaluations with regard to care, pruning, removal, fertilization, and pest management. David R. Ahlum shall perform other related duties as may be required or requested such as providing written inspection reports and providing testimony to the Bexley Tree and Public Gardens Commission.
