

The City Council (the "Council") of the City of Bexley, Ohio (the "City") met in regular session on 3-27-07, 2007 in Bexley City Hall in the City of Bexley, Ohio, with the following members present:

Mr. Lampe introduced the following resolution and moved its passage:

RESOLUTION NO. 3-07

AUTHORIZING THE USE OF A PORTION OF THE PROCEEDS OF BONDS OR BOND ANTICIPATION NOTES OF THE CITY, IN THE PRINCIPAL AMOUNT OF NOT TO EXCEED \$1,300,000.00 FOR THE PURPOSE OF IMPROVING AND REHABILITATING THE JEFFREY MANSION, WITH RELATED FACILITIES AND APPURTENANCES, TO REIMBURSE THE CITY'S GENERAL FUND, PERMANENT IMPROVEMENT FUND, OR OTHER CITY FUND FOR MONEYS PREVIOUSLY ADVANCED FOR SUCH PURPOSE

WHEREAS, the City may advance costs for the above-referenced purpose (the "Project") from its General Fund, Permanent Improvement Fund, or other City fund on hand; and

WHEREAS, the City desires to reimburse any such costs with a portion of the proceeds of bonds or bond anticipation notes hereafter to be issued (the "Obligations");

THE COUNCIL OF THE CITY OF BEXLEY HEREBY RESOLVES:

Section 1. The City intends that this resolution shall constitute an "official intent" for purposes of Section 1.150-2(e) of the Treasury Regulations prescribed under the Internal Revenue Code of 1986, as amended, and declares its intention to use a portion of the proceeds of the Obligations to reimburse the City for expenses of the Project advanced from its General Fund, Permanent Improvement Fund, or other City fund on hand.

Section 2. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this resolution were taken in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

Mr. McClelland seconded the motion and, after discussion, a roll call vote was taken and the results were:
