

AMENDED ORDINANCE 47-10

An Ordinance to establish rates for all salaried, part time and casual employees of the City of Bexley, effective as of January 1, 2011.

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO**

**Section 1.** That elected officials of the City of Bexley are to be paid in a manner prescribed by the Charter and Ordinances

**Section 2.** That all Schedule 1 employees are paid an annual salary calculated on the basis of an hourly rate multiplied by a 2080 hour work schedule per year as follows:




**Section 4.** That all above employees will be paid either weekly or biweekly as determined by management.


**Section 5.** That the provisions of this ordinance shall take effect as of January 1, 2011.

**Section 6.** That all ordinances or parts thereof which are inconsistent herewith are hereby repealed.

**Section 7.** That in order to assure uninterrupted City services, this Ordinance is an emergency measure, necessary for the immediate preservation of the public peace, health and safety and this ordinance shall go into effect upon its passage and approval by the Mayor, to be effective January 1, 2011.
