

Second Amended Ordinance 29-12

An Ordinance to Amend Chapter 262, Section 262.02 of the Codified Ordinances of the City of Bexley to correct editing errors in Amended Ordinance 53-11.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY OHIO:

Section 1. That any benefits provided to the police captain in Section 262 of the Bexley Code also be extended to the Police Chief in instances where the Police Captain and Police Chief were not listed together. These include 262.02(c) 2A, 5D, 7A, 12A, 14A, 16A, and 17A. All areas in the listed sections that include reference to the "Police Captain" shall be amended to read "Police Chief and Police Captain", as follows:

262.02(c) 2)A:

A. Police Chief and Police Captain. The Police Chief and Police Captain are entitled to the clothing allowance provided in the collective bargaining agreement governing uniformed members of the Bexley Police Department. (Ord. 25-98. Passed 3-16-98.)

262.02(c) 5)D:

D. Police Chief and Police Captain. Life, Health, and Dental & Vision insurance shall be provided to the Police Chief and Police Captain under the same terms and conditions as provided in the collective bargaining agreement governing the uniformed members of the Bexley Police Department.

262.02(c) 7)A:

A. The Police Chief and Police Captain shall be entitled to any longevity pay provisions that may be provided, from time to time, in the collective bargaining agreement governing uniformed members of the Bexley Police Department.

262.02(c) 12)A:

A. Police Chief and Police Captain. The Police Chief and Police Captain are entitled to sick leave accrual and use under the terms provided in the collective bargaining agreement governing uniformed members of the Bexley Police Department.

262.02(c) 14)A 1:

A. Grant.

1. Police Chief and Police Captain. The Police Chief and Police Captain are entitled to any vacation with pay provisions as provided, from time to time, in the collective bargaining agreement governing uniformed members of the Bexley Police Department.

262.02(c) 16)A:

A. Police Chief and Police Captain. If the Police Chief and Police Captain do not request and, are not granted sick leave, except bereavement leave pursuant to subsection (c)(1) hereof, during each three calendar months of continuous service, he or she shall, in addition to the accumulation of the sick leave, have the option of receiving one (1) day's pay or one (1) day off with pay, up to a maximum of two (2) days per calendar year. If the bonus option is elected, the bonus shall be paid as soon as practicable after it is earned and shall be in addition to all other pay and allowances. Vacation, personal days or injury leave may not be used in lieu of sick leave to qualify for the wellness payment.

262.02(c) 17:

17) Fitness Incentive for Police Chief and Police Captain. The Police Chief and Police Captain are entitled to the fitness incentives provided in the collective bargaining agreement governing uniformed members of the Bexley Police Department. (Ord. 32-09. Passed 6-9-09.)

Section 2. Section 262.02(c) 5) B. refers to co-payments between the City and covered employees. Amended Ordinance 53-11 changed numerical percentage amounts but the written percentages were not changed, creating an inconsistency. The written percentage terms are hereby amended so that the written and numerical percentage amounts are identical in meaning, and consistent with the original intent of Council. 262.02(c) 5 B is amended as follows


262.02(c) 5) B:

B. Health. A contract or contracts providing group health, hospital, surgical, major medical, dental and vision insurance with such benefits as shall be fixed annually by contract covering all employees. The City shall offer employees group health insurance coverage, with the City paying eighty percent (80%) and each covered employee paying twenty percent (20%) of the premium cost of the plan. Any co-payment shall be paid by each covered employee by automatic payroll deduction. (Ord. 108-00. Passed 1-23-01.).


Section 3. Due to the technical correction nature of this ordinance, rather than new legislation or change of previous Council intent, the provisions of this ordinance shall be treated as if they had been in effect and in force from and after January 1st 2012.
