

**AMENDED ORDINANCE 72-13**

An Ordinance to establish rates for the Mayor, salaried, part time and casual employees of the City of Bexley, effective as of January 1, 2014.

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO**

**Section 1.** That the Mayor will be paid \$102,515 which represents a 1.5% increase in accordance with Ordinance 58-12.

**Section 2.** That all other elected officials of the City of Bexley are to be paid in a manner prescribed by the Charter and Ordinances.

**Section 3.** That the Police Chief will be paid as follows: Beginning January 1, 2014 the pay rate will be \$114,779. Beginning July 1, 2014 the pay rate will be \$115,927. Beginning December 1, 2014 The pay rate will be \$117,086. The Police Chief will also receive a one time payment of \$1,705.

**Section 4.** That the Police Captain will be paid as follows: Beginning January 1, 2014 the pay rate will be \$100,977. Beginning July 1, 2014 the pay rate will be \$101,987. Beginning December 1, 2014 The pay rate will be \$103,007. The Police Captain will also receive a one time payment of \$1,500.

**Section 5.** That all Schedule 1 employees are paid an annual salary calculated on the basis of an hourly rate multiplied by a 2080 hour work schedule per year as follows:

**Section 8.** That all above employees will be paid either weekly or biweekly as determined by management.

**Section 9.** That the provisions of this ordinance shall take effect as of January 1, 2014.

**Section 10.** For Service Department Supervisors, as defined in Section 262 of the codified ordinances of the City of Bexley, the city will pick up eight and one-half percent (8 ½% ) of the employee's PERS contribution.

**Section 11.** That the position of Deputy Director of Development and Communication referenced in Section 5 of this Ordinance is hereby created effective January 1, 2014, that this is an unclassified position and that this position be added to pay Grade 5 category of Amended Ordinance 52-09.

**Section 12.** That all ordinances or parts thereof which are inconsistent herewith are hereby repealed.

**Section 13.** That in order to assure uninterrupted City services, this Ordinance is an emergency

measure, necessary for the immediate preservation of the public peace, health and safety and this ordinance shall go into effect upon its passage and approval by the Mayor, to be effective January 1, 2014.
