

ORDINANCE ____14

An Ordinance to establish rates for the Mayor, salaried, part time and casual employees of the City of Bexley, effective as of January 1, 2015.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO

Section 1. That the Mayor will be paid \$104,574 which represents a 2% increase in accordance with Ordinance 58-12.

Section 2. That all other elected officials of the City of Bexley are to be paid in a manner prescribed by the Charter and Ordinances.

Section 5. That all above employees will be paid either weekly or biweekly as determined by management.

Section 6. That the provisions of this ordinance shall take effect as of January 1, 2015.

Section 7. That all ordinances or parts thereof which are inconsistent herewith are hereby repealed.

Section 8. That in order to assure uninterrupted City services, this Ordinance is an emergency measure, necessary for the immediate preservation of the public peace, health and safety and this ordinance shall go into effect upon its passage and approval by the Mayor, to be effective January 1, 2015.
