 - i. Discussion of Public Service Garage Phase II bids -

Mr. Dorman explained the City originally bid the Garage Service Garage as one piece with the new building. Due to high cost of existing building renovation, we decided to build the garage in order to lower cost. He said the City was not able to go out and only rebid the renovation portion until the contractor was completed with the new building in February 1, 2015. The new building components of the renovation bid was done separately. Those came in high again. Mayor Kessler explained it was a small project which is why

we had such high estimates.

Mr. Dorman said he broke down the bids to HVAC, Electrical, Plumbing, and general construction. He spoke with Pat Devine and asked for a motion from Council to solicit bids and meet with our architects and then provide a few weeks to have them provide new bids. This is critical because the other bids are good and we don't want them to move on while we are trying to get the construction bid under control. Mayor Kessler explained does not want someone to not bid due to the ORC bid requirements. This scenario differs because it does have the smaller components. Mayor Kessler explained they estimated \$40,000 in cost and received bids for \$250,000. We will be going out to rebid the projects for all components with allowing the Mayor and Service Department to negotiate the bids. This action is required by Council.

Moved by Mr. Madison and Mr. Morison seconded to approve the non-statutory completion of the Phase II Construction Garage with prevailing wages.

We bid the Garage Service Garage as one piece with the new building and due to alternates, we went ahead and built the garage in order to lower cost. We were not able to go out and advertise the renovations until contractor was complete. Last bid was too high and then we bid them out separately. Mayor Kessler said it was a small project which is why we had such high estimates. Mr. Dorman said prices are peaking again in construction. We broke down the bids to HVAC, Electrical, Plumbing, and general construction. He spoke with Pat Devine and asked for a motion from Council to solicit bids and meet with our architects and then provide a few weeks to have them provide new bids. This is critical because the other bids are good and we don't want them to move on while we are trying to get the construction bid under control. Mayor Kessler explained we want to bid not using the ORC bid requirements. This is different because it does have the smaller components. We estimated \$40,000 cost and received bids for \$250,000. We will be going out to rebid the projects for all components with allowing the Mayor and Service Department to negotiate the bids. This is an action of Council-

Update on public comments rules and regulations for BZA and i. Planning Commission

Ms. Cunningham explained the difference between a public meeting and the quasi fiduciary meeting which would limit public comments. Mr. Madison asked if he could say a few comments before the meeting and before the quasi fiduciary hearing started if it is not considered testimony. Ms. Cunningham said she does not like that option because the decision making board is to use the evidence provided in the quasi hearing and might adversely or inadversely impact the decision they make.

Randy Waddel - Question regarding "prejudicial" interest. Does the Board have to make the decision of standing for every person. Ms. Cunningham said typically the Board doesn't know and no one asks, other times they might ask and the Board makes the decision as to whether or not you are adversely effected. If the Chair makes the decision, the Board can always overrule the Chair.

Mr. Waddell asked about whether or not it is something based on a zoning variance, how do we prevent that from helping and becoming a precedent.

Mr. Lewis asked if an individual is unhappy at the end of the procedure they can still go downtown to court and file as well if they had standing. Ms. Cunningham said if you don't have standing in Bexley, you probably won't have standing downtown in court, unless a Judge overrules that.

Mary Gottesman, supported Tim's request that there be some definition of standing and some description as to how someone can request standing. She thinks it would be helpful to residents to know what that means and how to ask for it. She said large parties of individuals should have a separate meeting from the hearing but people should be able to see in writing that they will still be guaranteed the right to be heard. Mr. Keyes said "standing" is a long held judicial concept that is determined based on the facts and circumstances of each situation.

 Technology: Mayor Kessler explained the status of the following:
 Review and modernize records retention policy: Mayor Kessler said the retention policy has been revamped and he has made sure that staff has a good understanding of the record keeping policy. Create a Main Street
 Wi-Fi infrastructure: Wi-Fi infrastructure was put on hold due to no real need for it with businesses having Wi-Fi, library, etc. so this may no longer be the best fit for Bexley.

Expand access to Wi-Fi at city facilities: We are continuing to work with the

schools regarding providing Wi-Fi in the Mayfield/Ferndale area. There are some security concerns to opening up the City's Wi-Fi and once we have fiber in place, we may be able to offer that service in a safe manner.

Audit and simplify technology infrastructure: We have made huge progress going from Novell to an active server environment which is simplifying the structure. We are doing a lot of sharing with our advanced 911 which is cojoined with Gahanna and Whitehall

Provide online payment options for residents and users. . We are working which would on a dispatcher backup system Gahanna dispatchers during an emergency. Cloud based solutions: Bexley Base is a cloud base solution and the departments are learning on how to use it in their work flow. Code Enforcement and Service Department probably get the most notices. Ms. Owen said Bexley was used as an example at the ED411.

Provide online payment options for residents and users: The City of Bexley Water Department went live for online payments this year but there is a fee to residents to use the credit card. The Mayor's Court software is over ten years old and does not have interface. The Building Dpt. has current software solution but does not have an online interface.

Communications: New resident packets sent just updated last month. Non-internet communications - hot line, Bexley Blast Telephone line. The newsletter sent with the Water Bill, Go Bexley web site, Main Street banner program, are about to have a coordinated banner program. Community Event signs in front of the community at Broad and Main. The electronic banner was not allowed by code. We have a limited amount of right of way to allow signs and open to suggestions to get signs out to people.

 - Bill Dorman, Service Director Mr. Dorman said the Mid Ohio ii. Regional Planning Commission (MORPC) announced their awards and the administrative staff has worked to try to get the City to a level to get funding. The City of Bexley was actually in the top five. The project is a 5.5 million dollar project for water line work, pavement restoration, new street lights on Ashbourne Place and Roosevelt (between Main and Broad) and signal at Fair and Roosevelt.

Our tree contractor just completed installing 143 trees. We are on our third and final round of leaf pickup which will include alleys. Mr. Harvey said the street grant project is great and congratulated Mr. Dorman. He said he wanted Council to recognize that part of those funds are loans, so they will need to be paid back. We should be able to start design work next year and construction in July at the earliest. Mr. Harvey said the repayment won't start until a couple of years after the project is completed. Mayor Kessler said this is about two miles of new water lines. Mr. Dorman said Roosevelt also needs paving work anyway so the timing is good. Mayor Kessler said Dave Koch has done a great job helping us apply for these projects. For the first time, we had public commentary at a meeting held at City Hall and this had a big impact on our scoring when people do care about improvements.
