Presentation by Erik McGuiness, IT Manager for his 2017 budget. He explained the expenses, cell phones, software licensing, granicus, etc. Any increases are attributable to closer accounting details based on past history experience. Open Gov will be included in the IT budget this year. The tech items include a new copier for the Rec. & Parks; this upcoming year will be hardware along with additional 17,000 for expansion of our security cameras. Ms. Owen asked about the Operating Expenses. Mr. McGuiness said he would like to add mileage within one City Hall account; printer ink, etc. The Mayor said the capital items are long term (Networking items). Mr. Harvey said once it is approved in the Capital budget, it can be spent as opposed to Erik coming back and asking if he can buy the copier. He said this is an important item for Council to understand. Mr. Keyes said he did meet with Erik regarding the technology budget for the Court and Ms. Feibel met with him regarding the rest of his budget. Annual expenses, PC costs, cruiser equipment (more day to day) items versus larger project based areas. Mayor Kessler said he is the tech support for the whole city and he has done very well.

g. Finance Committee Reports: Deneese Owen, Chair

Chief Rinehart presented his department's budget for 2017 to Council. He said the payroll items seem higher than normal but are from errors in the 2016 budget vs. 2017 budget.

The uniform budget is less on the line item only because he broke down this item into two line items. This is now listed under patrol equipment but consists totally of the uniform costs. He said he broke these items into two line items in order to make it a little easier to understand. He felt it was becoming two different things (not just uniforms). Chief Rinehart reviewed the budget regarding the advanced 911 system which is legally required to have, so those are forced costs. He said the training fund went up \$5,000 due to Lexipool which regularly reviews our Federal and State regulations to make sure our policies are up to date, including officer training. He has included two new police cars. The night vision in the police car has proved to be very significant and we would like to add this to other vehicles. We do have an electric motorcycle - very quiet and will last 5 to 6 hours. The Chief used it for when the President came to town to help with traffic grid on Frances. It is a hybrid bike - on and off road (allows you go in yards, sidewalk) and there are a total of five of us who are trained to use it. They did receive this motorcycle through a fully funded program. It is designed after a BMW motorcycle.

Mr. Sharp and the Chief met to discuss the budget. Ms. Feibel asked if the pit bull ordinance passed, would there be any additional funds needed for the police. Mayor Kessler said the volume will be low enough to handle it out of the budget.
