A RESOLUTION IDENTIFYING THE JEFFREY MANSION EXPANSION PROJECT AS A CITY INITIATIVE SUPPORTED BY BEXLEY CITY COUNCIL AS ONE OF COUNCIL'S PRIMARY 2017 GOALS.

WHEREAS, the Bexley Recreation and Parks Department has done an outstanding job expanding the department's programming for the City and has now outgrown the department's current space; and

WHEREAS, it is the desire of Council that the City provide the Recreation Department more space so as to enhance the department's ability to serve our community; and

WHEREAS, conceptual plans show renovation of the department's current garage and enclosing the carport would provide such space; and

WHEREAS, during the last three consecutive yearly Council retreats, council members have agreed that this project is one which should be completed; and

WHEREAS, City Council passed Resolution 05-08 adopting the Jeffrey Mansion Commission Master Plan for planning and restoration of the Jeffrey Mansion and Park attached as "Exhibit A".

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Bexley, Ohio:

Section 1. That Bexley City Council supports the Jeffrey Mansion Expansion project and directs the administration to move forward with plans so as to have the project underway in 2017.

Section 2. That this Resolution of Support shall take effect at the earliest date allowed by law.

AMENDED RESOLUTION NO. 05- 08

A Resolution recognizing the efforts made by the Jeffrey Mansion Commission and adopting the Jeffrey Mansion Commission Master Plan for future consideration, planning and restoration of the Jeffrey Mansion and Park.

WHEREAS, by Ordinance Nos. 83-06 and 10-07, the Jeffrey Mansion Commission was established to prepare a conceptual programmatic, operational and financial plan (the "Plan") for restoration and expansion of Jeffrey Mansion as a multi-purpose community center for recreational, educational and social uses as contemplated by the Bexley Heritage Fund Report received by Council on October 10, 2006; and

WHEREAS, the City in conjunction with volunteer members of the Commission, studied, planned, and prepared with Schooley Caldwell Associates, MSI, and guided in their efforts by Donna Laidlaw, the Plan for potential restoration, rehabilitation and redevelopment of the Jeffrey Mansion; and

WHEREAS, City Council has heard and reviewed the phases and options for the Plan as presented and reviewed in its open meetings; NOW, THEREFORE,

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

Section 1. This Council hereby expresses deep appreciation and gratitude to all persons assisting in the efforts of the Jeffrey Mansion Commission in evaluating, forming, and approving a Plan for the Jeffrey Mansion and Park.

Section 2. The Jeffrey Mansion and Park Plan prepared by the Jeffrey Mansion Commission and submitted to the Council is hereby accepted for future Council discussions concerning a quality restoration, rehabilitation, and redevelopment of the Jeffrey Mansion and Park. This Resolution in no way commits the City of Bexley to any financial obligations.

Section 3. Any recommendations proposed for the Jeffrey Mansion and Park concerning a quality restoration, rehabilitation and redevelopment of the Jeffrey Mansion and Park shall be first presented for approval by all appropriate regulatory bodies of the City of Bexley.
