ORDINANCE NO. 30-17

An Ordinance authorizing the Service Director to sign a Consent and Hold Harmless Agreement on behalf of the City of Bexley with the property owner at 2424 E. Main Street, for Kittie's, located in Suite 150, and previously known as 2418 E. Main Street, granting a right of encroachment regarding improvements made upon and within the City owned street right-of-way adjacent to Cassady Avenue, and a seasonal enclosure, located in the City owned street right-of-way adjacent to E. Main Street;

WHEREAS, a fence, patio, awnings, and seasonal enclosure, located in the City right-of-way on the east side of the building are approved and can remain in place as shown in Exhibit "A" attached (26'4" wide x 92" deep) and a seasonal enclosure, located in the City right-of-way on the south side of the building are approved and can be located as shown in Exhibit "B" attached (48" x 132"); and

WHEREAS, the owner of 2424 E. Main, Gramercy Partners LLC, constructed a patio and fence over a portion of the public walk adjacent to Cassady Avenue; and

WHEREAS, fencing, raised patios and seasonal enclosures are not permitted in the public right-of-way unless approved and a Consent and Hold Harmless Agreement are executed; and

WHEREAS, the Service Director has the authority to grant a public right-of-way certificate in accordance with Chapter 1028 of the City codified ordinances subject to conditions set by City Council that it deems to be reasonable;

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

Section 1.

That the Service Director is authorized to grant a public right-of-way for the patio, fence, awnings and seasonal enclosures within the public right-of-way at 2424 E. Main Street subject to the owner signing a Consent and Hold Harmless Agreement and subject to all applicable provisions of Chapter 1028 of the City of Bexley codified ordinances.

SIDE VESTIBULE PLAN VIEW





SIDE VESTIBULE

FASTENING SYSTEM FOR REMOVABLE PANELS



