

RESOLUTION NO. 16-18

AUTHORIZING THE MAYOR, OR CITY AUDITOR TO SEEK FINANCIAL ASSISTANCE FROM THE OHIO PUBLIC WORKS COMMISSION (OPWC) FOR FUNDING OF VARIOUS CAPITAL INFRASTRUCTURE IMPROVEMENT PROJECTS.

WHEREAS, pursuant to Article VIII, Section 2K of the Ohio Constitution, the State of Ohio is authorized to issue bonds and other obligations of the State for the purpose of financing public infrastructure capital improvements of political subdivisions as designated by law; and

WHEREAS, pursuant to Section 164.06 of the Ohio Revised Code (ORC), the District Three Public Works Integrating Committee has been created to accept, evaluate, and recommend applications for state financing of capital infrastructure improvement projects of political subdivisions in Franklin County; and

WHEREAS, pursuant to Section 164.05 of the ORC, the Ohio Public Works Commission has been created to accept and approve applications for state financing of capital infrastructure improvement projects of political subdivisions in Franklin County; and

WHEREAS, the City of Bexley has conducted a capital inventory and needs assessment and has determined that it is necessary to submit applications for financial assistance for capital infrastructure improvement projects.

NOW, THEREFORE, BE IT RESOLVED by the council of the City of Bexley, the State of Ohio and Franklin County that:

Section 1. The Mayor, or City Auditor is hereby authorized to apply to the District Three Public Works Integrating Committee and the OPWC for financial assistance for the following capital infrastructure improvement project:

South Cassingham Road and Vernon Road Comprehensive Improvements Project

Section 2. The Mayor, or Auditor is further authorized to enter into any agreements as may be necessary and appropriate for obtaining this financial assistance

Section 3. This resolution is for the preservation of public health, safety and welfare and shall be in full force and effect immediately upon passage by a majority of the City Council, and upon approval by the Mayor, or otherwise at the earliest time allowed by law.

BE IT FUTHER RESOLVED that a copy of this resolution will be transmitted to MORPC; and
