

ORDINANCE NO. 37-18

An Ordinance to amend Sections 1060.10 and 1060.105 of the Codified Ordinances of the City of Bexley to establish the rate for the collection and disposal of Solid Waste, Recyclable Materials and Yard Waste.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

Section 1. That sections 1060.10, 1060.105, 1060.11, 1060.12, 1060.13, 1060.14 and 1060.15 of the Codified Ordinances of the City of Bexley are amended to read as follows:

1060.10 CHARGES, CONDITIONS AND LIMITATIONS ON PARTICULAR COLLECTIONS.

(a) To provide necessary funds for equipment, personnel and other expenses in connection with the collection and disposal of solid waste, recyclable materials, yard and food waste in the City, a charge of three hundred and fourteen dollars and ninety nine cents (\$314.99) per year, payable quarterly in advance, commencing January 1, 2019, is hereby levied and assessed for the collection and disposal of solid waste, recyclable materials, yard and food waste from each residential unit. Whenever service begins between payment periods, a payment at the rate of one twelfth of the current annual charge per month, for the balance of the current period, shall be made before service commences. For periods of ten days or less in any one month, no charge shall be made, but eleven days or more shall be charged for a full month. No refund shall be made for any part of a payment if service is discontinued during such period.

1060.105 11 CHARGES TO SENIOR CITIZENS

(a) The refuse collection charges set forth in Section 1060.10(a) shall not apply to those senior citizens who are residents of the City of Bexley and occupy a Bexley residence, who maintain Bexley utility and refuse accounts in their own names for such residences, who are sixty (60) years of age or older, and who make application to the City Water Department for exemption from the refuse collection charges set forth in Section 1060.10(a).

(b) Senior citizens who meet all of the requirements set forth in subsection (a) hereof shall be billed for refuse charges at the rate of two hundred eighty-three dollars and forty-four cents (\$283.44) per year, payable quarterly in advance.

Section 2. That existing Sections 1060.10 and 1060.105 of the Codified Ordinances of the City of Bexley are hereby repealed.

Section 3. That this Ordinance is needed to implement the increase prior to the January 1, 2019 water billing period and shall go into effect upon its passage and approval by the Mayor.

Section 4. That the following sections be adjusted (renumbered) accordingly to account for changes to section 1060.105:

1060.~~12~~ 13 Delinquency and violations; discontinuance of service.

1060.~~13~~ 14 Independent contractors.

1060.~~14~~ 15 Claims against the City.

1060.~~15~~ 16 Unlawful accumulations.

BE IT RESOLVED, that the City Council of Bexley, Ohio does hereby authorize the Service Director to enter into an agreement with Rumpke of Ohio, Inc. that is substantially in accordance with Exhibit A, and Innovative Organics, that is substantially in accordance with Exhibit B.
