

ORDINANCE NO. 30-18

**This Ordinance is to certify special assessments for sidewalk repairs and replacement cost incurred by the City of Bexley in 2017**

WHEREAS, various property owners (exhibit A) throughout the City were notified of necessary sidewalk repairs abutting their property and ordered to do so by the City in accordance with the City of Bexley's Amended Ordinance 47-08,

WHEREAS, said property owners did not perform the necessary repairs, or opted to have the City perform this work and assess their property taxes,

WHEREAS, property owners shall be assessed (property tax bill) the real and full cost of said repairs,

WHEREAS, it was in the best interest of the public's health and safety for this work to be completed.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO:

Section 1. The assessment amounts reported, together with the description of said lot and parcel of land, are now on file with the Clerk of Council. Assessments are the actual cost to the City of Bexley for said services and are not in excess of the special benefits to said property and are not in excess of any statutory limitations.

Section 2. The total assessment against each lot or parcel of land shall be assessed to the property in two annual installments without interest.

Section 3. Assessment shall be certified by the Clerk of Council to the County Auditor, as provided by law, to be placed on the tax duplicate as a special assessment and collected as other taxes are collected.

Section 4. This Ordinance shall go into full force and effect at the earliest date allowed by law.
