

ORDINANCE 40-19

An Ordinance to establish rates for part time and casual employees of the City of Bexley, effective as of January 1, 2020.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BEXLEY, OHIO

Section 1. That all part time, temporary and casual employees will be paid hourly as follows:


Section 2. That all above employees will be paid biweekly.


Section 3. That the provisions of this ordinance shall take effect as of January 1, 2020.
