NARRATIVE FOR PATROL OFFICER MELLISON M DAVIS

Ref: 24BEX-15066-AR

On 9/17/2024 Bexley officers observed a vehicle with expired plates, which belonged to another vehicle, commit a marked lanes violation. Officers initiated a traffic stop and the driver did not pull over. The driver continued operating their vehicle at or below the posted speed limit. The driver committed several marked lanes violations and swiped and struck two separate curbs. Eventually, the driver pulled over outside the city. The driver passively and actively resisted arrest. The driver displayed signs of impairment and several open bottles of alcoholic beverages were located inside the vehicle. The driver was placed under arrest, read the BMV2255 and agreed to provide a breath sample. The driver was transported to BPD headquarters for processing where they were unable to provide a valid sample and were marked as a refusal. The driver was slated in to Franklin County Jail, Jackson Pike for Resisting Arrest, OVI, Fail to Comply, OVI-State, DUS-Non Compliance, Marked Lanes, and Display Tags of Another Vehicle.
