On 2-5-25 at approximately 1550, Bexley Police were dispatched to 5/3rd Bank, 2570 E. Main St., on a report of someone attempting to withdraw money whilst posing as an actual customer. I arrived with Sgt. Johnson II and observed Ofc. Moss, Ofc. Winnegrad, and Ofc. Schwarz taking four people into custody. These four people were in a vehicle located in the northern most teller lane. Sgt. Johnson II went to assist them and I went inside to talk to bank employees.

I spoke with Bryer Beavers. Mr. Beavers stated that, initially, the vehicle in question entered the drive thru facing the wrong direction. Further, it pulled up so that the back right passenger, later identified as Jennifer Martin, could be the one making any transaction. Mr. Beavers noticed that the identification she was using did not look real and that Ms. Martin would not look at the camera. Ms. Martin was using a fake Ohio identification card containing all of the victim's information. The victim was identified as Danille Froehle. Mr. Beavers looked up Ms. Froehle's account and found that she signed with an "L" as a middle initial. However, the withdraw slip that Ms. Martin filled out did not have an "L" signed.

Mr. Beavers then called Ms. Froehle who stated she was not at 5/3rd and was at home. Mr. Beavers then called the police. I made contact with Ms. Froehle later via phone who advised that she does not know a Jennifer Martin and would not authorize anyone to make such a transaction on her behalf.

Main Street by means of Identity Theft, in violation of Section 2913.49B-2 of the ORC, and Forgery, in violation of Section 2913.31A-1 of the ORC. Both offenses are felonies of the 5th degree. The suspect was transported to JAK without incident.
